- Images from Migraine Action must not be copied, stored or transmitted in electronic or other media unless by separate written permission, except where such is incidentally and wholly necessary to the process of production for products properly licensed by Migraine Action. At the conclusion of such production, all intermediate copies of this material must be destroyed.
